### PHOTOGRAPHIC REPRODUCTION SERVICES

The Special Collections and Preservation Division of the Chicago Public Library is pleased to offer photographic reproduction services for our collections. While we will attempt to accommodate the research and publication needs of our patrons, our reproduction service operates in strict compliance with U.S. Copyright Law and restricts reproductions when the condition of the original is deemed too fragile or the item is damaged.

Many of the items in the library's collections are no longer under copyright restriction. In some cases, however, determining the copyright holder can be difficult. To assist patrons, Special Collections makes information about copyright holders available in archival finding aids and other sources. **DETERMINING THE EXISTENCE OF COPYRIGHT OR ANY OTHER LEGAL RESTRICTIONS, AS WELL AS OBTAINING PERMISSION FROM THE COPYRIGHT HOLDER IS SOLELY THE RESPONSIBILITY OF THE REQUESTER.**

The Chicago Public Library encourages copyright holders who are not appropriately identified to contact the library so that we may provide more complete information.

### ORDERING PROCEDURES

1. Complete the attached *Order Form* and sign the *Conditions Governing Use* on the reverse. Be as specific as possible when requesting an item and use an accession number or call number to identify it. Complete information will expedite your request.
2. Turn in the completed form in person to the Special Collections and Preservation Division Reading Room on the Ninth Floor of the Harold Washington Library Center or fax it to 312-747-4890. **PAYMENT BY U.S. CHECK OR CASH IS DUE AT THE TIME THE ORDER IS PLACED.** Credit card payment is not accepted.

Orders take from ten working days to one month to complete and can be picked up in the Special Collections Reading Room or mailed. Special delivery services are not available. The Special Collections and Preservation Division of the Chicago Public Library is pleased to make reproductions of its collections available for personal and scholarly use. Items reproduced for commercial purposes and/or publication may be subject to copyright restrictions (see below).

All requests for photographic and digital reproductions are governed by the following conditions:

1. Reproductions are provided one-time, for personal use, research purposes or publication/exhibition only. Requesters wishing to use the same images for another use must make a separate request.
2. All images used in printed publications, on film and video, on web sites and in exhibitions are to be credited with the following: *Chicago Public Library, Special Collections and Preservation Division*
3. The requester is to give Special Collections one complimentary copy of any published work in which the photographic reproduction occurs.
4. In authorizing the publication of the reproduction, the Chicago Public Library does not surrender its own right to publish it, or to grant others permission to do so.
5. Granting permission to reproduce materials does not absolve requesters from securing permission from the copyright holder if the material is not in the public domain, nor does it affect the payment of additional fees as required by the copyright owner. *Users assume all responsibility for questions of copyright, invasion of privacy and rights of publicity that may arise in using reproductions from the library's collections.*
6. The Special Collections and Preservation Division reserves the right to limit the number of reproductions; restrict the reproduction service to Special Collections materials only; restrict the use of rare or fragile materials; and institute special fees for items requiring special handling.
7. Exceptions or additions to these conditions appear below and are considered a part of the conditions governing the use of reproductions provided by the Chicago Public Library.

EXCEPTIONS OR ADDITIONS TO THE ABOVE CONDITIONS:
