# **POLICY:**

- Virginia Mason offers a range of reproductive health services.
- Services include provision of contraception services and infertility treatment.
- In-vitro fertilization is not provided at Virginia Mason.
- Obstetrical care is provided at Virginia Mason.
- Pregnancy termination may be performed by some Virginia Mason physicians.
- Emergency contraception is available twenty-four-hours/seven-days per week in the Emergency Department and is offered to all victims of sexual assault.
