Definitions

- Obesity: Body Mass Index (BMI) of 30 kg/m² or higher.
- Body Mass Index (BMI): A measure of an adult's weight in relation to his or her height, calculated by using the adult's weight in kilograms divided by the square of his or her height in meters.

Method

- The data were collected through the Behavioral Risk Factor Surveillance System (BRFSS), an ongoing, state-based, telephone interview survey conducted by state health departments with assistance from CDC.
- Height and weight data used in the BMI calculations were selfreported.
- **Three years of data were combined to ensure sufficient sample size.**

Records with the following were excluded:

□ Height: <3 feet or ≥8 feet</p>


❑ Weight: <50 pounds or ≥650 pounds</p>


Summary

- 1 state (Hawaii) and the District of Columbia had a prevalence of obesity less than 20%.
- 3 states (California, Colorado, New Mexico) and Guam had a prevalence of obesity between 20% and <25%.</p>
- 17 states and Puerto Rico had a prevalence of obesity between 25% and <30%.</p>
- □ 21 states had a prevalence of obesity between 30% and <35%.
- 7 states (Arkansas, Iowa, Indiana, Oklahoma, Kentucky, Mississippi, and West Virginia) had a prevalence of obesity of between 35% and <40%.
- □ No state had a prevalence of obesity 40% or greater.



- **12** states had a prevalence of obesity between 30% and <35%.
- 10 states and the District of Columbia had a prevalence of obesity between 35% and <40%.</p>
- **25** states had a prevalence of obesity 40% or greater.



- **20** states had a prevalence of obesity between 35% and <40%.
- 2 states (Indiana and Michigan) had a prevalence of obesity 40% or greater.
